# Hosley India Private Limited - ISSUER NOT COOPERATING due to Non-Submission of No Default Statement (NDS)

### Rationale

ICRA has moved the rating of **Hosley India Private Limited** to the '**ISSUER NOT COOPERATING**' category due to non-submission of monthly 'No Default Statement' ("NDS") by the entity.

ICRA has been consistently following up with **Hosley India Private Limited** for obtaining the monthly 'No Default Statement'. However, the entity's management has remained non-cooperative and ICRA has not received NDS for two consecutive months of March 2023 and April 2023.

ICRA is unable to validate whether **Hosley India Private Limited** has been able to meet its debt servicing obligations in a timely manner. Accordingly, the lenders, investors and other market participants are advised to exercise appropriate caution while using this rating.
