Rationale

ICRA has kept the long-term rating of Villupuram District Co-Operative Milk Producers Union Limited in the 'Issuer Not Cooperating' category. The rating is denoted as [ICRA]B+(Stable); ISSUER NOT COOPERATING.

As part of its process and in accordance with its rating agreement with Villupuram District Co-Operative Milk Producers Union Limited, ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

Villupuram District Cooperative Milk Producers Union Ltd, established as cooperative society in 1982 is involved in processing and manufacturing of milk and its byproducts. The Union sells products such as Milks, curds, milk powder, ghee, butter, ice cream, sweets, among others under the brand name "Aavin" predominantly in Tamil Nadu. It has a milk processing capacity of 1 lakh litres per day, ghee production capacity of 2 MT/day with chilling capacity of 1.5 lakh litres at Villupuram and 1 lakh liters at China Salem.

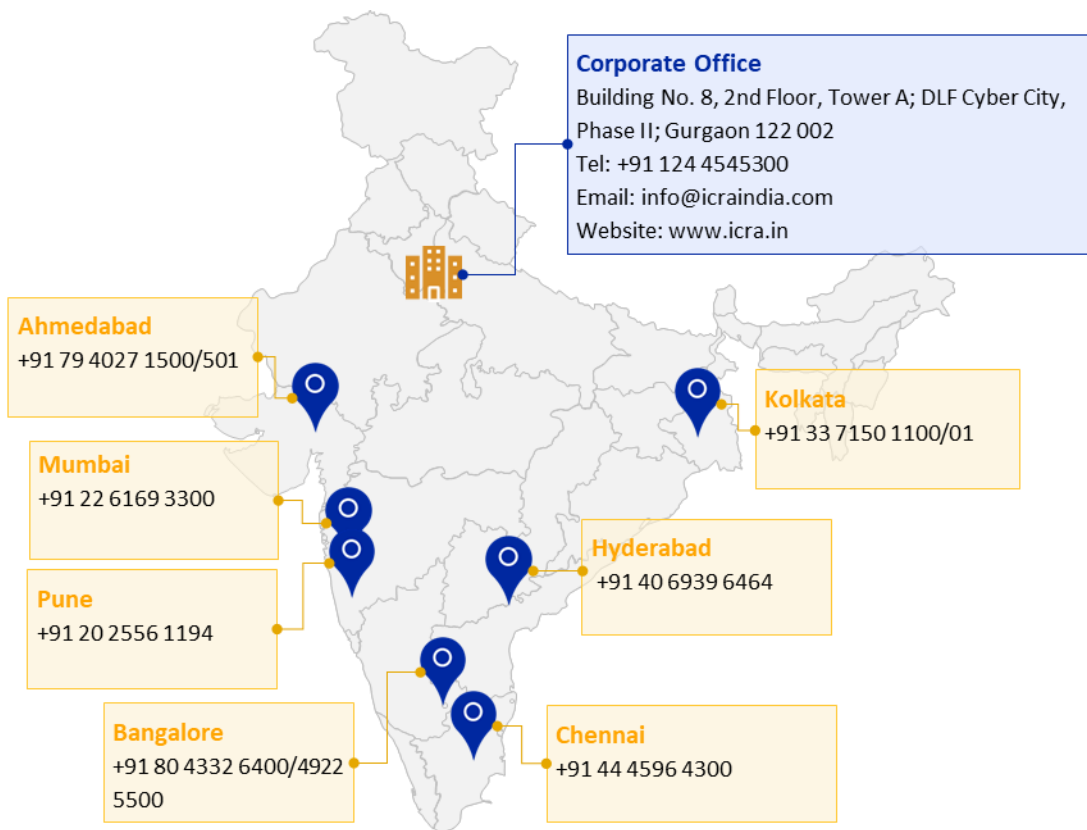
