Rationale

ICRA has kept the Long-term and Short Term rating of Maberest Hotels Private Limited in the 'Issuer Not Cooperating' category. The ratings are denoted as [ICRA]D; ISSUER NOT COOPERATING."

As part of its process and in accordance with its rating agreement with Maberest Hotels Private Limited, ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

About the company

MHPL, incorporated on May 29, 1972, own sand operates the 103-room business hotel "Hotel Fidalgo" at Panjim in Goa. The company is promoted by Mr. Jayant Shetty and is closely held. The property was running under the name "Hotel Fidalgo" under a different management till 1998-99 when it was closed down and put up for sale. Mr. Jayant Shetty then purchased it as an asset buyout in 2002-03. Post his purchase, Mr. Shetty refurbished the hotel, added new restaurants and started the hotel again in phases (October 2005 and October 2006) under the same name "Hotel Fidalgo". During FY 2016, MHPL also started operations of new discotheque "Nyex beach club" at Anjuna, Goa. The hotel is situated at a prime location on 18th June Road which is the CBD of Panjim
