Rationale

ICRA has kept the long-term and short-term rating of Platinum Polymers Private Limited in the 'Issuer Not Cooperating' category. The ratings are denoted as [ICRA]B+(Stable)/[ICRA]A4; ISSUER NOT COOPERATING"

As part of its process and in accordance with its rating agreement with Platinum Polymers Private Limited, ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

(PPPL) was incorporated in 2007 and is engaged in manufacturing of flexible packaging material such as stretch cling film, laminated pouches and bags, air bubble film, and Bi-Axially Oriented Polypropylene (BOPP) woven fabric. The company is promoted by Mr. B.P. Poshia and Mr. Mitesh Poshia, who have over two decades of experience in the packaging industry. The company is also involved in the trading of machinery on a small scale. PPPL also manufactures pouches on a job-work basis for other packaging material manufacturers. The manufacturing facility of the company is located at Badlapur, near Mumbai.
