Rationale

ICRA has kept the long-term and short-term ratings for the bank facilities of Svr Laboratories Private Limited in the 'Issuer Not Cooperating' category. The ratings are denoted as "[ICRA]B+ (Stable) ISSUER NOT COOPERATING/[ICRA]A4 ISSUER NOT COOPERATING".

As part of its process and in accordance with its rating agreement with Svr Laboratories Private Limited, ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

SVRLPL was incorporated in the year 2003 and started its commercial production in the year 2008. The company was acquired by its current directors in the year 2010. SVRLPL was primarily into the production of Pantoprazole (PPZ) intermediates and has a manufacturing facility in Nalgonda, Telangana with a total capacity of 150 KL. The company has four directors: Mr. P Nageswara Rao, Mr. V V Ravi Kumar, Mr. Murali Krishna, and Mrs. P Naga Durga. The promoters also own SVR Drugs Private Limited (SVRDPL) with a plant in Vishakhapatnam which was started to meet increased demand.
