Rationale

ICRA has kept the Long-Term and Short-term rating for the Bank facilities of Sigma Chemicals in the 'Issuer Not Cooperating' category. The rating is denoted as "[ICRA]B+(Stable); ISSUER NOT COOPERATING/[ICRA]A4; ISSUER NOT COOPERATING".

As part of its process and in accordance with its rating agreement with Sigma Chemicals, ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

Sigma Chemicals (SC) was established in 1984 as a proprietorship concern in Indore (Madhya Pradesh) by Mr. Vijay Goyal. SC is a (i) carrying and forwarding (C&F) agent of lubricants for IOCL in Eastern Madhya Pradesh and also a (ii) Del-credre cum consignment agent for IOCL's polymers in Madhya Pradesh and Chattisgarh. The promoter's family has an experience of over 30 years in the polymer trading business. Being a DCA of IOCL for polymers restricts SC from trading in similar polymers through other sources. Subsequently, Mr. Vijay Goyal promoted Sigma Chemtrade Private Limited in 2007 to expand presence in polymer business through imports.

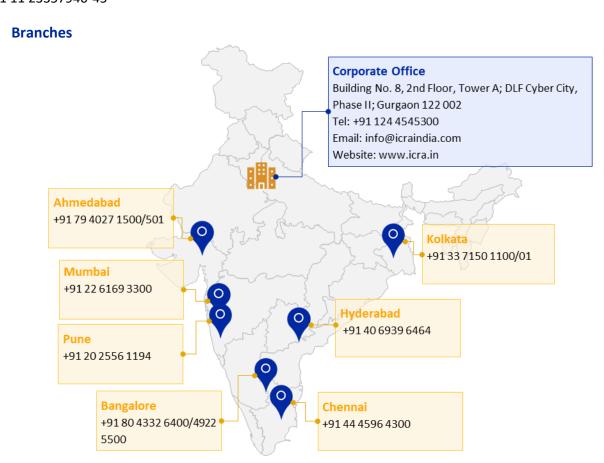
