#### Rationale

ICRA has kept the Issuer rating of Boduppal Municipal Corporation in the 'Issuer Not Cooperating' category. The rating is denoted as "[ICRA]B+ (Stable); ISSUER NOT COOPERATING".

As part of its process and in accordance with its rating agreement with Boduppal Municipal Corporation, ICRA has been trying to seek information from the entity so as to monitor its performance Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

## **About the company**

Boduppal Municipal Corporation (BMC), an ULB, was initially established as a Municipality in 2016 by merging Boduppal and Chengicherla Gram Panchayats of Rangareddy district, Telangana. The ULB's status was upgraded to a Municipal Corporation in 2019. The ULB provides urban infrastructure services to the city of Boduppal and is governed by the Telangana Municipalities Act 2019. The BMC covers an area of 20.53 sq. km. and serves a population of 1.45 lakh (projected as of 2021). It's main functions include solid waste management and construction, repair and maintenance of roads and streetlights. The ULB has 28 municipal wards and is governed by an elected body (Council) headed by a Mayor, while the Commissioner acts as the chief executive, overseeing its everyday functioning.
