Rationale

ICRA has kept the Long-Term and Short-term rating for the Bank facilities of Symcom Communication in the 'Issuer Not Cooperating' category. The rating is denoted as "[ICRA]B+(Stable); ISSUER NOT COOPERATING/[ICRA]A4; ISSUER NOT COOPERATING".

As part of its process and in accordance with its rating agreement with Symcom Communication, ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

About the company

Established in 1995, M/s. Symcom Communication is a proprietorship concern of Mr. Gopal Goyal. Earlier Symcom was engaged in supplying telephones to MTNL as well as dealing in scrap procured from telecom equipments. However, due to saturation in business from MTNL, Symcom ventured into disposing of scrap from sick industrial units in 2005. Sick units are purchased either from the official liquidator appointed by the high court or Debt Recovery Tribunal, through bidding process at auctions held by the official liquidator. Symcom also purchases scrap generated by Government corporations and the Indian Railways. Auctions for procuring this source of scrap are undertaken by MSTC Limited. Further Symcom also purchases scrap and sick units, at auctions held by private auctioneers such as Ashvin & Co. Auctioneers. Due to the favourable factors for ship breaking in 2009-10, Symcom undertook to ship breaking a source of scrap. The ship breaking activities are carried out at Mumbai and Alang, Gujarat.
