Rationale

ICRA has kept the long-term rating of RSV Hospital Private Limited in the 'Issuer Not Cooperating' category. The ratings are denoted as [ICRA]B+(Stable); ISSUER NOT COOPERATING"

As part of its process and in accordance with its rating agreement with RSV Hospital Private Limited, ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

RSV Nursing Home & Speciality Diagnostic Centre was set up in 2007 as an Association of Persons (AOP) by Mr. Rattan Sagar Vasisht along with his family members. In 2009, the centre was renamed as RSV Hospital. The AOP was reconstituted as a private limited company in 2011. The company operates a multi-specialty hospital in Kolkata called RSV Hospital, which is a 100-bed facility including six intensive-care units and services across specialties such as gynaecology, obstetrics, neonatology, cardiology, general medicine, orthopaedic and pediatric, among others. RSV Hospital generates most of its revenue from obstetrics and neonatology.
