Rationale

ICRA has kept the Long Term Ratings of Great Value Fuels Private Limited in the 'Issuer Not Cooperating' category. The rating is denoted as [ICRA]B+ (Stable); ISSUER NOT COOPERATING.

As part of its process and in accordance with its rating agreement with Great Value Fuels Private Limited, ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

About the company

Great Value Fuels Private Limited (GVF) was incorporated in 2008 and had entered into an agreement with Department of Transport (DoT), Government of Delhi to run public buses in Delhi. The DoT Govt of Delhi has launched a scheme to corporatize the Private Stage Carriage operation of buses in Delhi and appointed Delhi Integrated Multi Modal Transit System Limited (DIMTS) as Integrated Mechanism for the Private stage carriage buses corporatization scheme. Under the contract, GVF had to deploy 365 buses (292 Non-AC, & 73 AC).
