#### Rationale

ICRA has kept the Long-Term rating for the Bank facilities of JHV Steels Limited in the 'Issuer Not Cooperating' category. The rating is denoted as "[ICRA]B(Stable);ISSUER NOT COOPERATING".

As part of its process and in accordance with its rating agreement with JHV Steels Limited, ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

The company is engaged in the manufacturing of TMT bars with a production capacity of 1,00,000 tons per annum (TPA). The manufacturing facilities are located at Mirzapur in Uttar Pradesh. JHV has also setup a manufacturing unit for mild steel billets in its existing plant with an installed capacity of 75,000 TPA. The commercial production of the billet unit commenced in June' 2016.
