Rationale

ICRA has kept the Long-Term and Short-term ratings of Sita Ram International LLP in the 'Issuer Not Cooperating' category. The rating is denoted as [ICRA]B+(Stable)/[ICRA]A4; ISSUER NOT COOPERATING".

As part of its process and in accordance with its rating agreement with Sita Ram International LLP, ICRA has been trying to seek information from the entity so as to monitor its performance Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

About the company

SRIL, established in 2018, is a part of much larger Sita Ram Group and is in the business of trading timber. It is promoted by Mr. Sarthak Singhal and Mrs. Anuradha Singhal. SRIL has offices in Delhi, Kutch and Gandhidham. The firm's factory in Gandhidham, Gujarat is spread across an area of 9 acres and operates a total of 16 saw mills. Major proportion of SRIL's income is generated from sales of hardwood and pinewood products. It imports hardwood and pinewood logs from various countries like Malaysia, Africa, Canada etc., which are sawn in firm's Gandhidham based facility and sold in the domestic market. SRIL's other business segments includes trading of branded spruce wall panels and manufacturing of flush door shutters. The branded spruce wall panels imported from various countries including Germany, Russia etc. command high demand in domestic market and contribute to a considerable portion of SRIL's total operating income. SRIL has also established flush door manufacturing unit in Gandhidham. Apart from these major business segments, the firm also deals in block boards, dust wood, firewood, waste wood and birch plywood. However, currently, the sales of these products are very small.
