Rationale

ICRA has kept the Issuer rating of Mahalakshmi Leasing Limited in the 'Issuer Not Cooperating' category. The rating is denoted as "[ICRA]B-(Stable); ISSUER NOT COOPERATING".

As part of its process and in accordance with its rating agreement with Mahalakshmi Leasing Limited, ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

It is closely held by the Yama Family; Veeresh Yama is the Managing Director (MD). Although the Reserve Bank of India (RBI) cancelled MLL's non-banking financial company (NBFC) certificate of registration (CoR) in 2003, it remained in the lending business till H1 FY2019.
