Rationale

ICRA has kept the Long-Term and Short-Term ratings of LE Marble Gallery Private Limited in the 'Issuer Not Cooperating' category. The ratings are denoted as "[ICRA]B+(Stable); ISSUER NOT COOPERATING/[ICRA]A4; ISSUER NOT COOPERATING".

As part of its process and in accordance with its rating agreement with LE Marble Gallery Private Limited, ICRA has been trying to seek information from the entity so as to monitor its performance Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

About the company

Established in 1996, Le Marble Gallery Private Limited is primarily engaged in retailing sanitary ware, marble and tiles. The company's showroom is located at Kozhikode in Kerala, spread across about 25,000 sq. ft. The promoters of the company, Mr. Abdul Majeed and Mr. Viju Thomas, have been engaged in similar businesses since 1996. LMGPL trades in imported as well as indigenous products. Branded tiles, sanitary ware and fittings constitute its import products, procured mostly from Spain. The company also trades in renowned Indian brands and has own brand of tiles—Titles. Moreover, LMGPL also procures marble blocks, which are cut into 20mm width pieces and sold as unbranded products. Some of the key brands sold by the company are Nitro, Somany Ceramics, Kajaria, Toto (Japan), Colorker (Spain), Roca (Spain), Kohler (USA) and Duravit (Germany). The company also has eight channel partners across Kerala, who help in marketing and selling its products.


