Rationale

ICRA has kept the Long-Term rating of Rajamahendravaram Municipal Corporation in the 'Issuer Not Cooperating' category. The rating is denoted as "[ICRA]B+(Stable); ISSUER NOT COOPERATING".

As part of its process and in accordance with its rating agreement with Rajamahendravaram Municipal Corporation, ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

About the company

The RMC was upgraded to a municipal corporation in 2005 from a selection-grade municipality. RMC is governed by the Andhra Pradesh Municipal Corporations Act 1994 (Act). It manages the municipal services in Rajamahendravaram city, located in the East Godavari district in coastal Andhra Pradesh. RMC covers an area of 44.5 square kilometres (sq. km.) and serves a population of 3.4 lakh (as per Census 2011). Its major functions include water supply, solid waste management and construction, repair and maintenance of roads and streetlights in its area. Divided into 50 municipal wards, an elected body

headed by a Mayor administers the corporation while the Commissioner acts as the executive head overseeing its everyday functioning.
