Rationale

ICRA has kept the Long-Term ratings for the Bank facilities of S S Super Foods Private Limited in the 'Issuer Not Cooperating' category. The rating is denoted as "[ICRA]B+(Stable) ISSUER NOT COOPERATING".

As part of its process and in accordance with its rating agreement with S S Super Foods Private Limited, ICRA has been trying to seek information from the entity so as to monitor its performance Further. ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

About the company

S S Super Foods Private Limited (SSSFPL) was incorporated in February 2020 as a special purpose vehicle by three promotor families. The company is in process of setting up a cattle feed manufacturing facility through PPP mode in Chikkaballapur, Karnataka. It has a lease agreement for land and supply agreement for 15 years with Karnataka CoOperative Milk Producer's Federation Limited (KMF) rated [ICRA]A+(Stable)/A1+ to supply cattle feed. The company plans to set up a 500 MTPD capacity plant with a project cost of ~Rs. 87.16 crore which is likely to commence its operations from September 2022.
