### Rationale

ICRA has kept the long-term ratings of MVP Group International Inc in the 'Issuer Not Cooperating' category. The rating is denoted as [ICRA]D ISSUER NOT COOPERATING".

As part of its process and in accordance with its rating agreement with MVP Group International Inc, ICRA has been trying to seek information from the entity so as to monitor its performance Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

### About the company

MVP Group International, Inc. (MVP) is involved in the manufacturing, import and distribution of scented candles. They sell primarily to large, national retailers like Wal-Mart1, Dollar General2 etc., and also (to a lesser extent) to small, local retailers. The Company sells mostly to retailers throughout the United States. MVP sells scented candles under two broad categories, private label candles (85% of the annual sales) and branded candles (15% of the annual sales). In addition, the Company does contract manufacturing of candles for other national brand owners. In FY18, the company has spun off its contract.


