Rationale

ICRA has kept the Long-Term rating of Ramapriya Solar Energy Private Limited in the 'Issuer Not Cooperating' category. The rating is denoted as "[ICRA]B(Stable); ISSUER NOT COOPERATING".

As part of its process and in accordance with its rating agreement with Ramapriya Solar Energy Private Limited, ICRA has been trying to seek information from the entity so as to monitor its performance Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

Ramapriya Solar Energy Private Limited (RSEPL) was incorporated in May 2015 as a Special Purpose Vehicle (SPV) to set up 2 MW Solar Power Project in Chitradurga District, Karnataka under the Farmer's Scheme allotted to Mr. T R Bheemaneedi. The solar power plant is expected to be commissioned in October 2016 and a Power Purchase Agreement (PPA) has been signed by SPD with BESCOM for a period of 25 years.

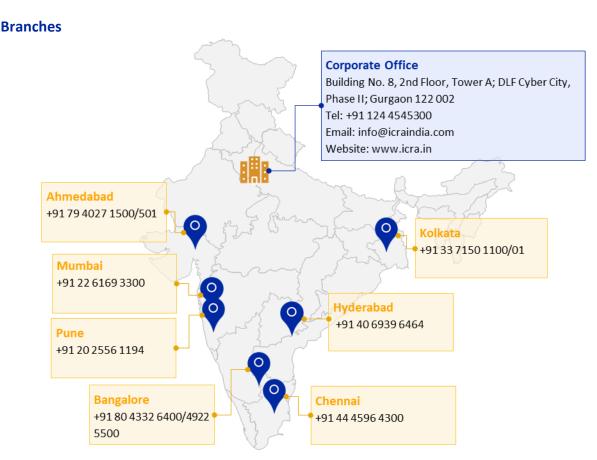
