Rationale

ICRA has kept the short-term ratings of Gallant Jewelry in the 'Issuer Not Cooperating' category. The rating is denoted as "[ICRA]A4; ISSUER NOT COOPERATING".

As part of its process and in accordance with its rating agreement with Gallant Jewelry, ICRA has been trying to seek information from the entity to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite repeated requests by ICRA, the entity's management has remained non-cooperative. In the absence of the requisite information and in line with the aforesaid policy of ICRA, the rating has been moved to the "Issuer Not Cooperating" category. The rating is based on the best available information.

Incorporated in 2001, Gallant Jewelry is a partnership firm based in Jaipur, Rajasthan. It manufactures and exports silver and gold-based studded jewelry. In 2006, the firm shifted its manufacturing base to a special economic zone in the Sitapura Industrial Area of Jaipur. The firm currently has an annual manufacturing capacity of 2000 kg of silver jewelry, 150 kg gold jewelry and 400 kg brass jewelry. The exports are primarily to the USA, Germany, the UK, Italy and Hong Kong.
