Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. About the company

RIGHILL ELECTRICS PVT LTD (REPL/the company) was incorporated in 1993 as a private limited company by Mr. Ashutosh Shukla and Mr. Vinod Sapre. The company designs and manufactures control systems and assemblies for various applications, including oil field equipment. It also manufactures parts and assemblies like electronic control modules, printed circuit boards (PCBs), plug and socket connectors, etc. REPL specialises in designing and manufacturing controls and electric parts for oil rigs. The major revenue is derived from the sale of rig equipment, and thus the revenues largely depend on the rigging activity, and in turn on crude oil prices. It also provides services pertaining to repairs and maintenance and offers annual maintenance contracts (AMC) to its customers. The company has an employee base of 50 engineers, who provide on-site services to customers. The manufacturing facility of the company is located at Bhopal in Madhya Pradesh.
