Rationale

ICRA has kept the Long-Term ratings of RAYANI SPIN-TEX PRIVATE LIMITED in the 'Issuer Not Cooperating' category. The rating is denoted as "[ICRA]B(Stable); ISSUER NOT COOPERATING".

As part of its process and in accordance with its rating agreement with RAYANI SPIN-TEX PRIVATE LIMITED, ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

Rayani Spintex Private Limited (RSPL) was established by Mr. Rayani Venkateswarlu, Mr. Borra Uma Maheshwara Rao and Mr. Unnava Subba Rao in 2007 and is based in Guntur, Andhra Pradesh. RSPL has commissioned the cotton spinning mill of 11,520 spindles in November'2011 and further increased to 14,400 spindles in May 2015. The company caters to domestic as well as international markets and is largely into manufacturing of 32s to 40s counts of cotton yarn.

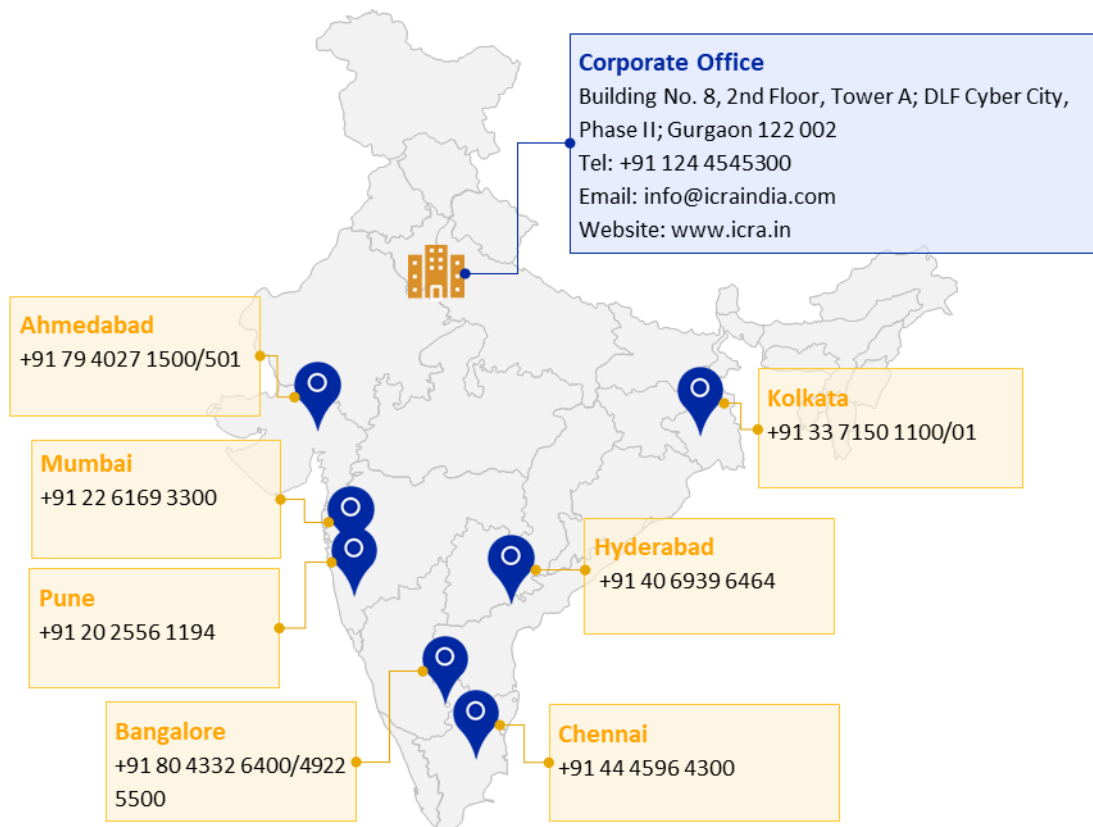
