Rationale

ICRA has kept the Long-Term and Short-Term ratings of Green Petro Fuels Llp in the 'Issuer Not Cooperating' category. The ratings are denoted as "[ICRA]B (Stable); ISSUER NOT COOPERATING/[ICRA]A4; ISSUER NOT COOPERATING".

As part of its process and in accordance with its rating agreement with Green Petro Fuels Llp, ICRA has been trying to seek information from the entity so as to monitor its performance Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

Green Petro Fuels LLP (GPF) was incorporated in November 2012 for establishing light diesel oil manufacturing facility (in Raipur) by Tirubhala Chemicals Private Limited (owned by Mr. Monish Johri) and Mr. Santosh Dwidevi. The entity has a production capacity of 60,000 MT for blending oils to manufacture light diesel oils for industrial use. GPF utilized around 16% of its installed capacity in FY2017 at a production level of 9500MT.

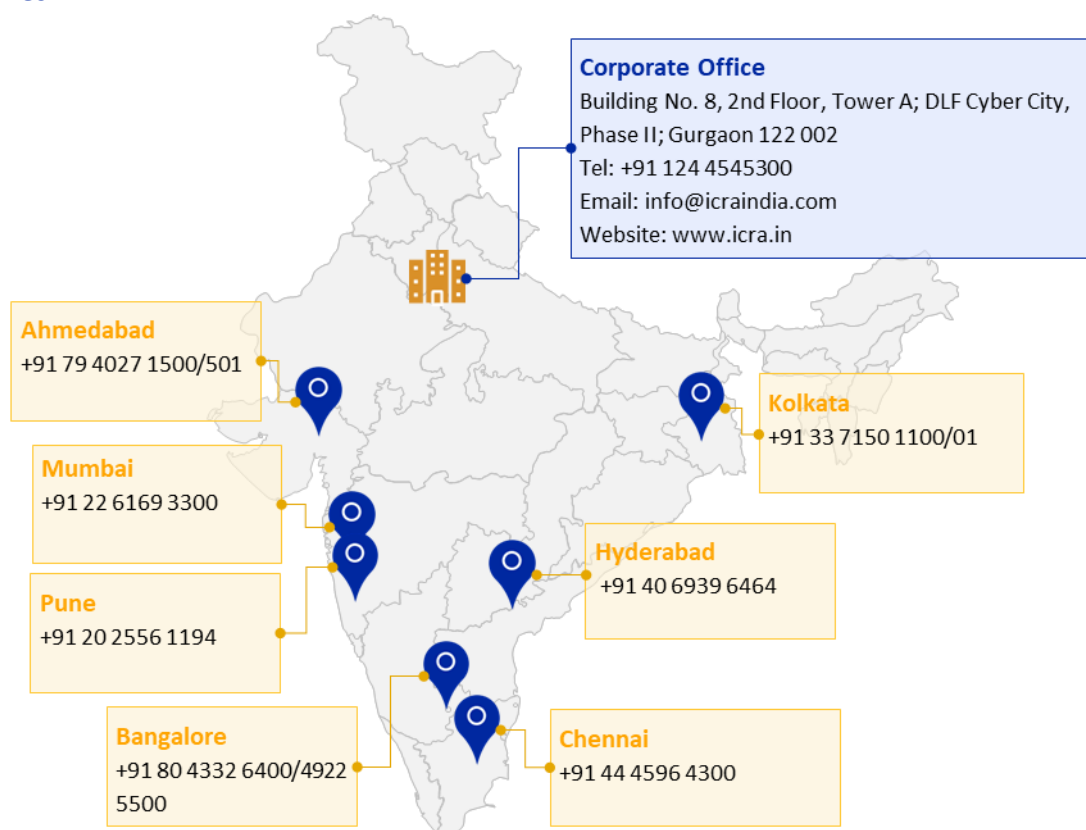
