Rationale

ICRA has kept the long-term rating of Adilabad Municipality in the 'Issuer Not Cooperating' category. The rating is denoted as [ICRA]B+(Stable); ISSUER NOT COOPERATING"

As part of its process and in accordance with its rating agreement with Adilabad Municipality, ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the afore said policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

About the company

Adilabad Municipality (AM) provides civic services to the Adilabad town, located in the Adilabad district in Telangana. It is governed by the provisions of the Telangana Municipalities Act 2019. The AM covers an area of 50.69 square kilometre (sq. km.) and the projected population is 1,80,390 for 2021 (1,55,968 as per Census 2011). The major functions of the AM involve water supply, sewerage, solid waste management, repair and maintenance of roads and street lighting in its area. An elected body, headed by a Chairperson, administers the municipality. The Commissioner acts as the executive head and oversees the day-to-day functioning of the ULB.

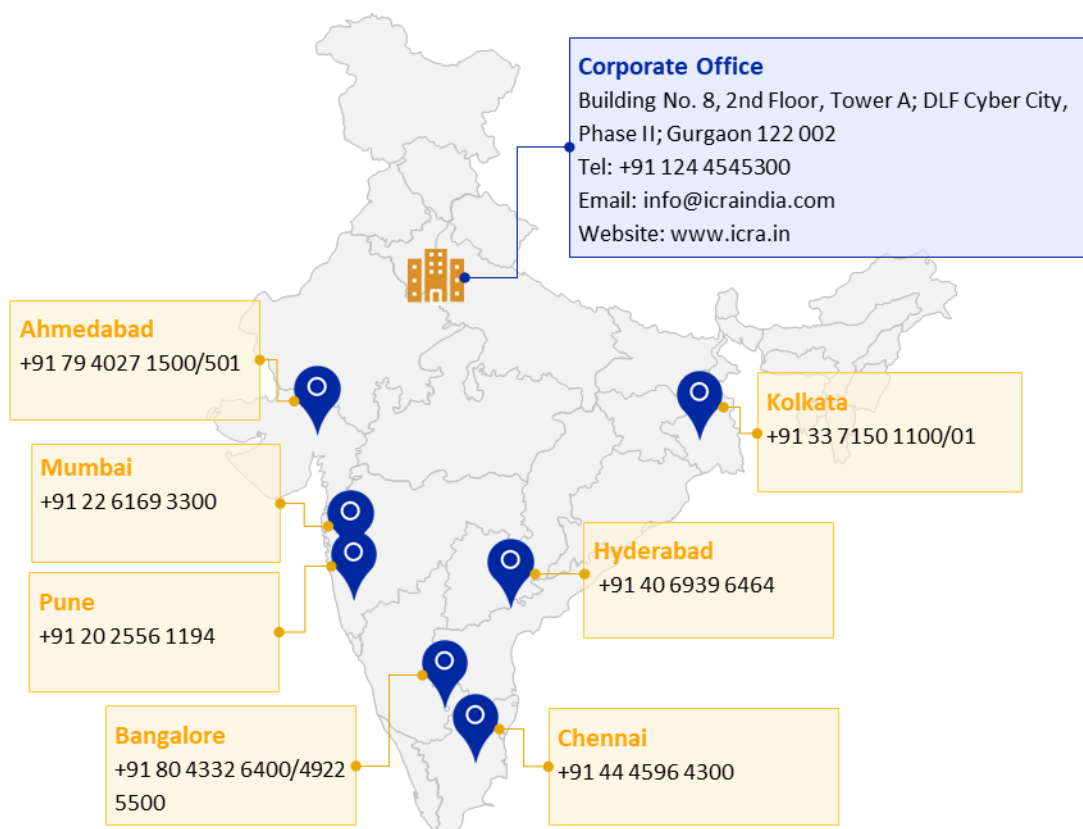
