Rationale

ICRA has kept the Long-Term ratings of Indian Pulp & Paper Private Limited in the 'Issuer Not Cooperating' category. The rating is denoted as "[ICRA]D; ISSUER NOT COOPERATING".

As part of its process and in accordance with its rating agreement with Indian Pulp & Paper Private Limited, ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

About the company

The company was incorporated in 2004 by the Kolkata-based Agarwal family in the name of Balaji Kagaz Private Limited. In 2006, it acquired Indian Paper Pulp Company Limited (IPPCL) from the Government of West Bengal and subsequently its name was changed to Indian Pulp & Paper Private Limited (IPPL). IPPL, at present, manufactures kraft paper (with 16-30 burst factor)

by recycling of waste paper. Its manufacturing facility is in Naihati, West Bengal with a capacity of 45,000 metric tonnes (MT) per annum.

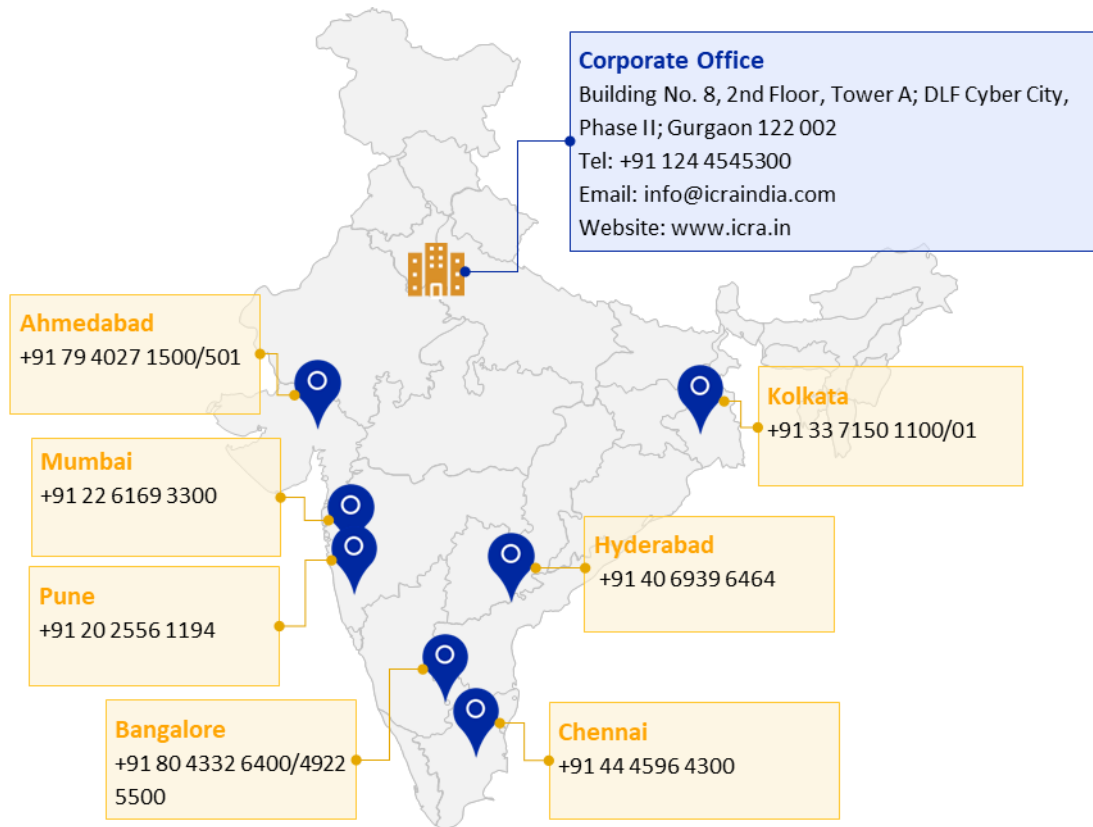
