### Rationale

ICRA has kept the Long-Term and Short-Term ratings of Lok Enterprises in the 'Issuer Not Cooperating' category. The ratings are denoted as "[ICRA]D; ISSUER NOT COOPERATING/[ICRA]D; ISSUER NOT COOPERATING".

The rating continues to remain under "Issuer Not Cooperating" is because of lack of adequate information regarding Lok Enterprises's performance and hence the uncertainty around its credit risk. ICRA assesses whether the information available about the entity is commensurate with its rating and reviews the same as per its "Policy in respect of non-cooperation by a rated entity" available at [www.icra.in](http://www.icra.in). The lenders, investors and other market participants are thus advised to exercise appropriate caution while using this rating as the rating may not adequately reflect the credit risk profile of the entity.

As part of its process and in accordance with its rating agreement with Lok Enterprises, ICRA has been trying to seek information from the entity so as to monitor its performance further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

## About the company

Established in 2002 as a partnership firm, LE is a trading house engaged in trading of various forms of pulses and beans into the domestic market. The firm has its registered office in Mumbai and a warehouse facility located in Vashi, Navi Mumbai. The firm undertakes import of pulses and beans and supplies it into domestic markets. The agricultural products comprise of raw pulses such as Masoor (split red lentils), Moong (split yellow lentil), Chana (chickpeas), Black eye bean, Toor Whole, Pinto bean etc. The traded goods are largely procured directly from international market. About 75% of the materials are sourced from Africa, Canada, USA, Argentina, Burma and Russia, while the remaining 25% are procured domestically.

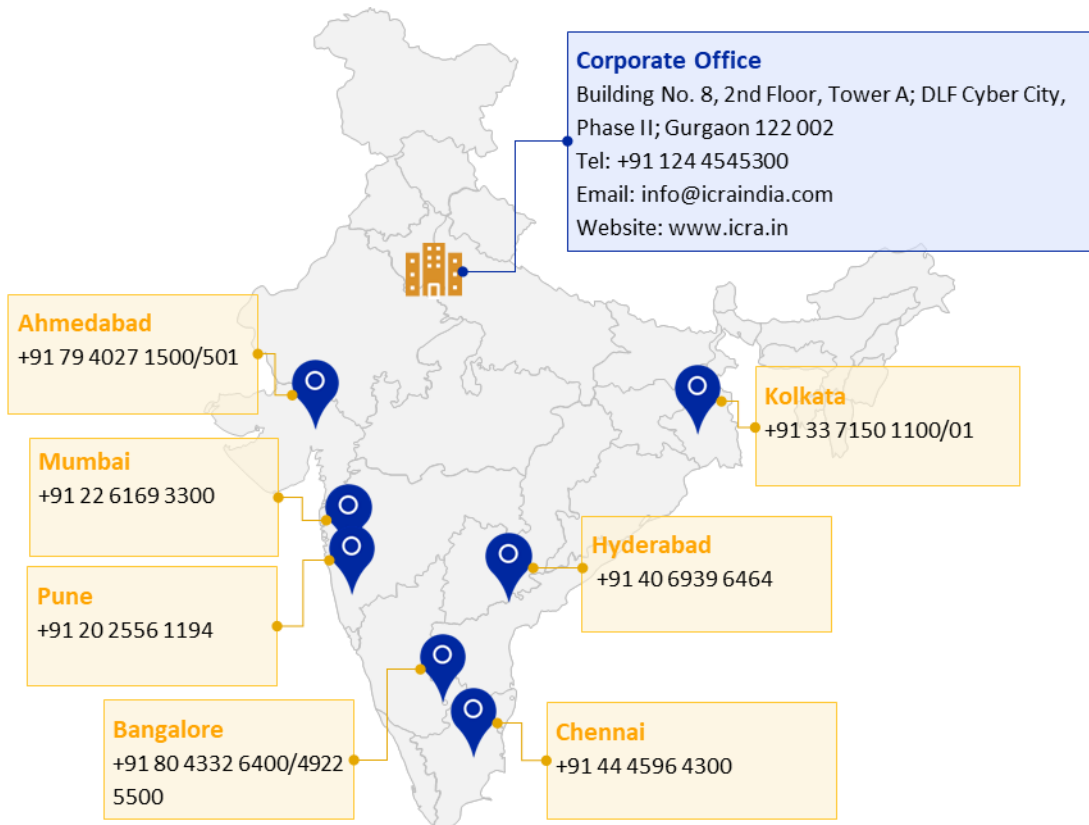
