Rationale

ICRA has kept the Long-Term ratings of Dev Bhoomi Frozen Food Products in the 'Issuer Not Cooperating' category. The ratings are denoted as "[ICRA]B(Stable); ISSUER NOT COOPERATING".

The rating continues to remain under "Issuer Not Cooperating" is because of lack of adequate information regarding Dev Bhoomi Frozen Food Products's performance and hence the uncertainty around its credit risk. ICRA assesses whether the information available about the entity is commensurate with its rating and reviews the same as per its "Policy in respect of non-cooperation by a rated entity" available at www.icra.in. The lenders, investors and other market participants are thus advised to exercise appropriate caution while using this rating as the rating may not adequately reflect the credit risk profile of the entity.

As part of its process and in accordance with its rating agreement with Dev Bhoomi Frozen Food Products, ICRA has been trying to seek information from the entity so as to monitor its performance further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

About the company

Established in 2014, Dev Bhoomi Frozen Food Products (DBFF) is involved in the processing of fruits and vegetables through Individual Quick Freezing (IQF) technology for preservation. Its day-to-day operations are looked after by Mr. Yogesh Jain and Mr Vinesh Jain, having profit sharing of 50% each. Both the partners were earlier engaged in trading of frozen vegetables and fruits, and packaged food. The firm has a production capacity of 5,300 Metric Tonnes Per Annum (MTPA) at its unit located at Kashipur (Uttarakhand). The major products that can be processed by the firm include green peas, cauliflower, bean, carrot, okra, litchi, mango, and corn; the firm proposes to source these from adjoining areas of Udham Singh Nagar and Nainital located in Uttarakhand. However, the firm is processing green peas in its initial period of operations.
