### Rationale

ICRA has withdrawn the ratings assigned to the bank facilities of Radiant Hotels Private Limited in accordance with its withdrawal policy and closure of the rated facilities, as evidenced by the No Due Certificate issued by the lenders. Consequently, there are no dues pending from Radiant Hotels Private Limited towards the rated bank facilities, and the withdrawal is based on the confirmation received from the lenders regarding the same. The company was initially incorporated with the objective of developing and running a hotel. Accordingly, the land was purchased in 1995-96, but the unit was not established. Now the company has decided to construct a residential housing project on the same property. The promoters have been engaged in the activity of cutting, polishing and trading of gems for the last 30 years. The firm is currently developing residential villas, consisting of total 30 villas of various sizes at Tonk Road, Jaipur, with a saleable area of 1.50 lakh sq. ft.
