### Rationale

ICRA has kept the Long-Term and Short-Term ratings of Radiant Energy Solutions Pvt. Ltd. in the 'Issuer Not Cooperating' category. The ratings are denoted as "[ICRA]B(Stable); ISSUER NOT COOPERATING/[ICRA]A4; ISSUER NOT COOPERATING".

The rating continues to remain under "Issuer Not Cooperating" is because of lack of adequate information regarding Radiant Energy Solutions Pvt. Ltd.'s performance and hence the uncertainty around its credit risk. ICRA assesses whether the information available about the entity is commensurate with its rating and reviews the same as per its "Policy in respect of non-cooperation by a rated entity" available at [www.icra.in](http://www.icra.in). The lenders, investors and other market participants are thus advised to exercise appropriate caution while using this rating as the rating may not adequately reflect the credit risk profile of the entity.

As part of its process and in accordance with its rating agreement with Radiant Energy Solutions Pvt. Ltd., ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

Incorporated on February 2015, Radiant Energy Solutions Private Limited (RESPL) is engaged in manufacturing fibre glass rod (FRP), silicon rubber compound, composite polymeric insulator and single-phase energy meter. It has an installed manufacturing capacity of 4,000 pieces per day of composite polymeric insulators and 3,000 pieces per day of energy metres. The company commenced commercial production of composite polymeric insulators from April 2016, while that of energy metres began from August 2017. The promoters - Mr. Arvind Kalaria, Mrs. Archana Patel and Mr. Atul Patel, have extensive experience in the energy industry through their association with other group concern, Radiant Ceramic Private Limited, which is engaged in manufacturing ceramic glaze tiles, insulators and allied activities.
