### Rationale

ICRA has kept the Long-Term and Short-term ratings of Iris Computers Limited in the 'Issuer Not Cooperating' category. The rating is denoted as "[ICRA]B+(Stable); ISSUER NOT COOPERATING/[ICRA]A4; ISSUER NOT COOPERATING".

The rating continues to remain under "Issuer Not Cooperating" is because of lack of adequate information regarding Iris Computers Limited's performance and hence the uncertainty around its credit risk. ICRA assesses whether the information available about the entity is commensurate with its rating and reviews the same as per its "Policy in respect of non-cooperation by a rated entity" available at [www.icra.in](http://www.icra.in). The lenders, investors and other market participants are thus advised to exercise appropriate caution while using this rating as the rating may not adequately reflect the credit risk profile of the entity.

As part of its process and in accordance with its rating agreement with Iris Computers Limited, ICRA has been trying to seek information from the entity so as to monitor its performance Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

## About the company

ICL was founded in 1996 by Mr. Sanjiv Krishen along with Mrs. Kamini Talwar and Mr. Som Arya. The company is involved in the trading and distribution of computer hardware, peripherals, and accessories. It is an authorised distributor of technology products of hardware majors like IBM, HP, Lenovo, Dell and HCL in India. In FY2014, Inflexion point Acquisition Corporation (Inflexion point), a global consolidator of IT supply chain companies, through Inflexion point Technologies Pte Limited or ITPL (its step-down subsidiary), acquired a 90% stake in Iris. In FY2015, DTD acquired ITPL. Post DTD's bankruptcy, all shares of ITPL were purchased by ZinX Worldwide FZE, UAE (owned by Ms. Anjali Krishen). The previous directors of ITPL have resigned and have been replaced by Mr. Sanjiv Krishen and Ms. Anjali Krishen. The remaining 10% shares of Iris remain with Mr. Sanjiv Krishen
