### Rationale

ICRA has kept the Long-Term and Short-Term ratings of Shreyans Oils Limited in the 'Issuer Not Cooperating' category. The rating is denoted as "[ICRA]B+(Stable); ISSUER NOT COOPERATING/[ICRA]A4; ISSUER NOT COOPERATING".

The rating continues to remain under "Issuer Not Cooperating" is because of lack of adequate information regarding Shreyans Oils Limited's performance and hence the uncertainty around its credit risk. ICRA assesses whether the information available about the entity is commensurate with its rating and reviews the same as per its "Policy in respect of non-cooperation by a rated entity" available at [www.icra.in](http://www.icra.in). The lenders, investors and other market participants are thus advised to exercise appropriate caution while using this rating as the rating may not adequately reflect the credit risk profile of the entity.

As part of its process and in accordance with its rating agreement with Shreyans Oils Limited, ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

## About the company

Shreyans Oils Limited (SOL) was incorporated in 1992 by Mr. Jayant Singh Dullo and others. The company manufactures crude rice bran oil (RBO) and de-oiled rice bran cake (DORBC) at its Ludhiana (Punjab)- based manufacturing facility. The plant has a total installed capacity of 200 metric tonnes per day (MTPD). It is only into solvent extraction and sells the crude oil to the oil refiners to the nearby regions. The company procures rice bran from the rice millers in the near byregions of Punjab and Haryana.

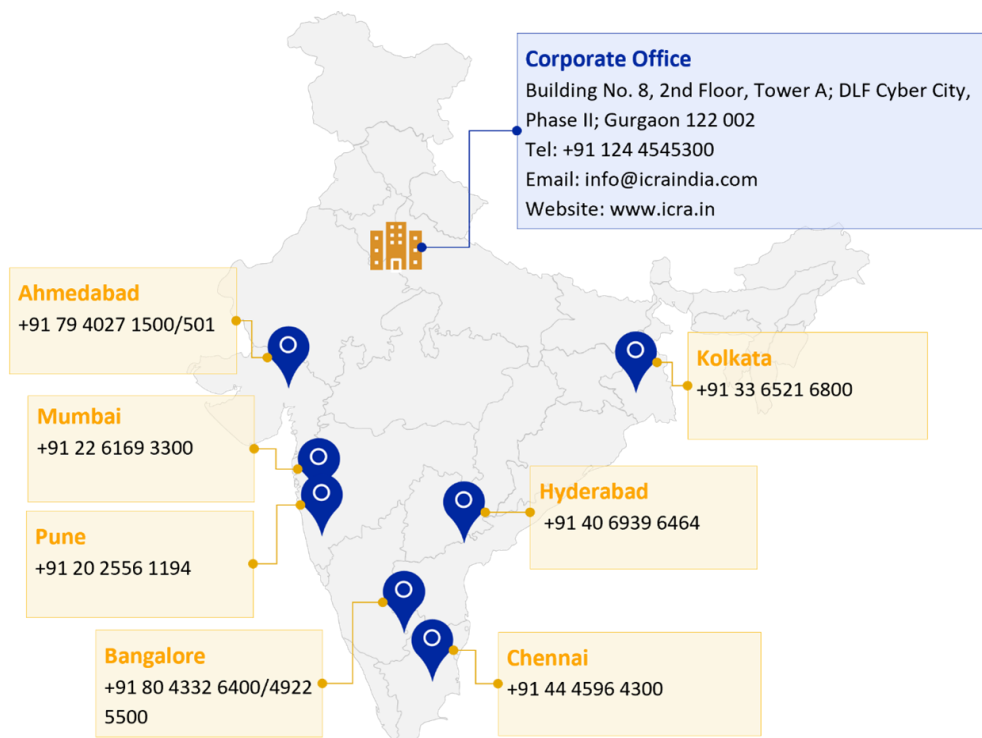
