Rationale

ICRA has kept the Long-Term and Short-Term ratings of Chidambaram Shipcare Private Limited in the 'Issuer Not Cooperating' category. The ratings are denoted as "[ICRA]B+(Stable); ISSUER NOT COOPERATING/[ICRA]A4; ISSUER NOT COOPERATING".

The rating continues to remain under "Issuer Not Cooperating" is because of lack of adequate information regarding Chidambaram Shipcare Private Limited's performance and hence the uncertainty around its credit risk. ICRA assesses whether the information available about the entity is commensurate with its rating and reviews the same as per its "Policy in respect of non-cooperation by a rated entity" available at www.icra.in. The lenders, investors and other market participants are thus advised to exercise appropriate caution while using this rating as the rating may not adequately reflect the credit risk profile of the entity.

As part of its process and in accordance with its rating agreement with Chidambaram Shipcare Private Limited, ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

About the company

Chidambaram Shipcare Private Limited (CSPL) was set up by Mr. K. Chidambaram in 1979 to provide afloat ship repair services and fabrication services at shipyards and ship building yards. Currently, apart from providing these services, CSPL also has dealership and service support agreements with:

- Volvo India Private Limited for marine propulsion and genset engines, spare parts and accessories;
- SMAG Peiner Grabs (India) Private Limited for grabs; and
- Optimarin for ballast water treatment systems.

CSPL is a registered Ship Repair Unit (SRU) with the Directorate General of Shipping for rendering afloat ship repair services. It currently has a workshop at the Chennai Port and another at Darukhana, near the Mumbai Port, which act as the base for its southern and western operations, respectively.
