## Radheshyam Cottex: Continues to remain under issuer non-cooperating category

### Rationale

ICRA has kept the Long-Term ratings of Radheshyam Cottex in the 'Issuer Not Cooperating' category. The rating is denoted as "[ICRA]B+(Stable); ISSUER NOT COOPERATING"

The rating continues to remain under "Issuer Not Cooperating" is because of lack of adequate information regarding Radheshyam Cottex's performance and hence the uncertainty around its credit risk. ICRA assesses whether the information available about the entity is commensurate with its rating and reviews the same as per its "Policy in respect of non-cooperation by a rated entity" available at [www.icra.in](http://www.icra.in). The lenders, investors and other market participants are thus advised to exercise appropriate caution while using this rating as the rating may not adequately reflect the credit risk profile of the entity.

As part of its process and in accordance with its rating agreement with Radheshyam Cottex, ICRA has been trying to seek information from the entity so as to monitor its performance further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

### About the company

Radheshyam Cottex was acquired from M/s Shah Govardhandas Bhikharidas. It was subsequently established as a partnership firm in November 2010 by Mr. Mahavirsinh Vala and four other partners, who collectively have experience of over a decade in the cotton industry. RC is engaged in the ginning and pressing of cotton. The manufacturing facility of the firm is located at Jasdan, in the Rajkot district of Gujarat. The facility is equipped with 20 ginning machines and a pressing machine, with a production capacity of around 15,780 cotton bales per annum.
