### Rationale

ICRA has kept the Long-Term and Short-Term ratings of Vicon Ceramic Private Limited in the 'Issuer Not Cooperating' category. The ratings are denoted as "[ICRA]B+(Stable); ISSUER NOT COOPERATING/[ICRA]A4; ISSUER NOT COOPERATING".

The rating continues to remain under "Issuer Not Cooperating" is because of lack of adequate information regarding Vicon Ceramic Private Limited's performance and hence the uncertainty around its credit risk. ICRA assesses whether the information available about the entity is commensurate with its rating and reviews the same as per its "Policy in respect of non-cooperation by a rated entity" available at [www.icra.in](http://www.icra.in). The lenders, investors and other market participants are thus advised to exercise appropriate caution while using this rating as the rating may not adequately reflect the credit risk profile of the entity.

As part of its process and in accordance with its rating agreement with Vicon Ceramic Private Limited, ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due. Despite multiple requests by ICRA, the entity's management has remained non-cooperative. In the absence of requisite information and in line with the aforesaid policy of ICRA, the rating has been continued to the "Issuer Not Cooperating" category. The rating is based on the best available information.

Incorporated in June 2013, Vicon Ceramic Private Limited (VCPL) manufactures wall tiles and parking tiles. The manufacturing facility of the company is located at Morbi, Gujarat, having an installed capacity to manufacture 54,000 Metric Tons of tiles. VCPL is promoted and managed by Mr. Amarshi Detroja and other directors associated with Coral Group and Somany Ceramic

Limited (SCL), having extensive experience of more than two decades in the ceramic industry. SCL acquired 26% stake in VCPL in January 2014 and currently off-takes VCPL's majority production.
