ICRA has withdrawn the ratings assigned to the bank facilities of Rpl Projects Limited in accordance with its withdrawal policy and closure of the rated facilities, as evidenced by the No Due Certificate issued by the lenders. Consequently, there are no dues pending from Rpl Projects Limited towards the rated bank facilities, and the withdrawal is based on the confirmation received from the lenders regarding the same.
