Rationale

ICRA has withdrawn the rating assigned to the bank facilities of Azure Power (Rajasthan) Private Limited at the company's request, based on the No Objection Certificate (NOC) received from its banker, and in accordance with ICRA's policy on withdrawal of credit ratings. ICRA does not have any information to suggest that the company's credit risk has changed since the time the ratings were last reviewed.

About the company

Azure Power (Rajasthan) Private Limited, a wholly-owned subsidiary of Azure Power India Private Limited was incorporated in June 2010. APRPL has set up a 5 MW (AC) solar power plant located at Kathauti in Jayal, District Nagaur, Rajasthan. The project was fully commissioned in December 2011. The company has signed a 25-year long-term PPA with NRVN for the entire capacity at a fixed tariff of Rs.11.94/kWh.

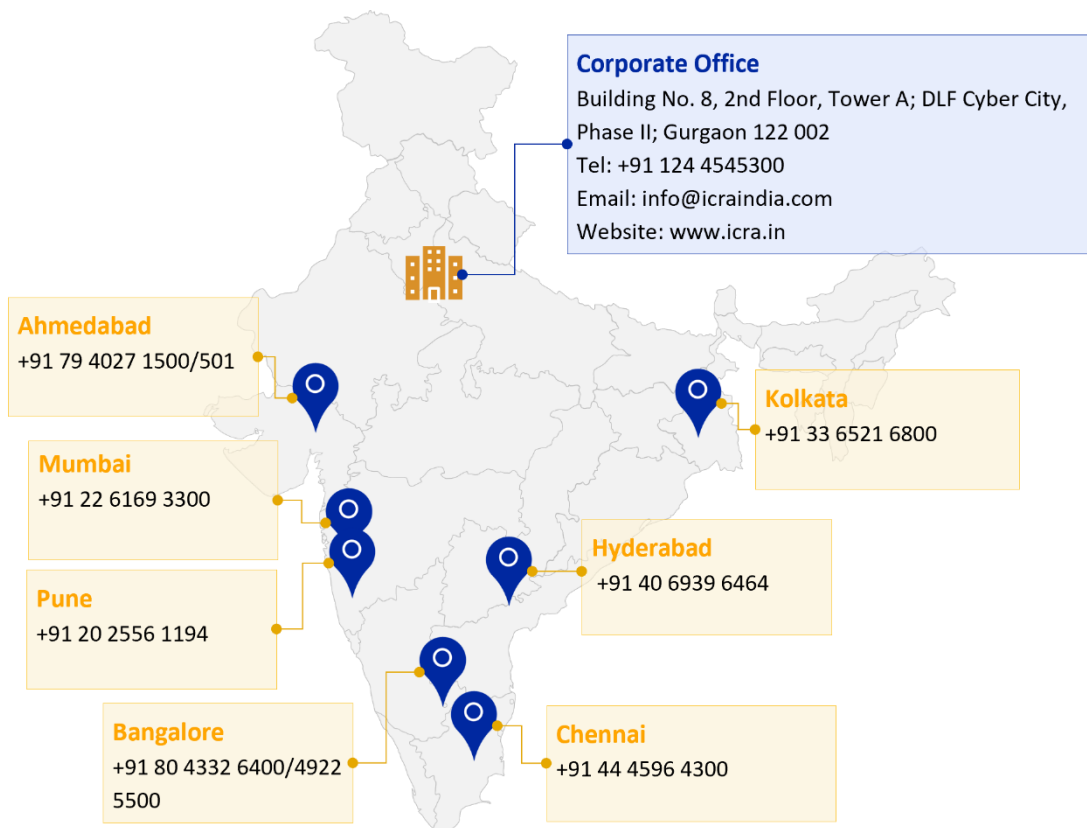
