The project consists of construction of 304 units 1 and 2 BHK fully furnished and equipped service apartments housed on a land admeasuring 8,215 Sq meters having a total saleable area admeasuring ~3.71 lac square feet.

HHL is a part of M.K Group founded and established by the Kheni and Patel families in 1987. The group has diversified operations across various industries such as imports and exports of diamonds, textiles, mining, real estate construction etc.
