

# ICRA Limited Change in rating suffix based on SEBI Guidelines

In accordance with the circular issued by the Securities and Exchange Board of India (SEBI) on June 13, 2019, titled 'Guidelines for Enhanced Disclosures by Credit Rating Agencies (CRAs)', and the subsequent clarifications provided by SEBI, ICRA has amended the notation of the (SO) suffix used alongside the rating symbols.

The following broad principles have been adopted to decide the suffix applicable:

### RATINGS WHICH WILL NOW CARRY THE (CE) SUFFIX

- » All ratings where the credit enhancement is external (i.e from a third-party) and the third-party is not a bankruptcy remote entity
- » All ratings which are backed by a pledge of shares or other assets

#### **RATINGS WHICH WILL NOT CARRY ANY SUFFIX**

- » All ratings which do not have any explicit credit enhancement
- » All ratings where the credit enhancement is internal ( i.e on account of structuring around cash flows) but the rated instrument is not bankruptcy remote of the entity / originator
- » In cases where there the rated instrument is backed by a third-party guarantee / involves structure around cash flows, but ICRA believes that the guarantee or the structure does not enhance the rating of the instrument (over and above the entity's unsupported credit profile)
- » GOI (Government of India) fully serviced bonds

#### RATINGS WHICH WILL CONTINUE TO CARRY THE (SO) SUFFIX

- » All ratings where the credit enhancement/ structure around cash flows leads to rated instrument being bankruptcy remote to the entity/ originator such as securitization transactions
- » Mutual fund ratings assigned to the capital protection oriented schemes

#### The change in suffix is not to be construed as a change in the rating.
