### About the company:

Tadepalligudem Municipality was established in 1958 and was upgraded to a selection grade municipality in 2010. The municipality is governed by the Andhra Pradesh Municipalities Act, 1965, which is administered by the Municipal Administration and Urban Development Department (DMA), GoAP. The TPGM provides basic municipal services in Tadepalligudem town, which is located in the west Godavari district of Andhra Pradesh. The TPGM covers an area of 20.71 square kilometre (sq. km.) and serves a population of 1.04 lakh (as per Census 2011). The major functions of the TPGM include water supply, solid waste management and construction, repair and maintenance of roads and streetlights in its area. The municipality is divided into 35 wards and is supervised by an

elected body, the council, consisting of ward councillors, elected for a period of five years. The council further elects a Mayor, who heads the deliberative wing of the corporation. The Commissioner, appointed by the State Government, heads the executive wing of the urban local body, and is responsible for all the activities carried out by the corporation.
