Rationale

ICRA has moved the long term and short term ratings for the bank facilities of CHVV Subba Rao (CHVVSR) to the 'Issuer Not Cooperating' category. The rating is now denoted as "[ICRA]B+ (Stable)/A4 ISSUER NOT COOPERATING"

ICRA has been trying to seek information from the entity so as to monitor its performance, but despite repeated requests by ICRA, the entity's management has remained non-cooperative. The current rating action has been taken by ICRA basis best available/dated/ limited information on the issuers' performance. Accordingly the lenders, investors and other market participants are advised to exercise appropriate caution while using this rating as the rating may not adequately reflect the credit risk profile of the entity.

CHVV Subba Rao was incorporated as a proprietorship concern in 1995 to undertake civil engineering projects pertaining to the comprehensive protected water supply and sanitation (CPWS&S) in Andhra Pradesh. The civil work includes laying of pipelines for water supply, tapping of surface water, construction of filtration plants for brackish water and fluoride water etc, construction of over-head tanks etc. The entity executes these projects for the Government of Andhra Pradesh under various schemes of Andhra Pradesh Rural Water Supply and Sanitation (RWS&S). At present, the firm is executing a railway project for the West-Central Railways.
