### Rationale

ICRA has withdrawn the ratings assigned to the bank facilities of ABC Transformers Private Limited in accordance with its withdrawal policy and closure of the rated facilities, as evidenced by the No Due Certificate issued by the lender. Consequently, there are no dues pending from ABC Transformers Private Limited towards the rated bank facilities, and the withdrawal is based on the confirmation received from the lenders regarding the same.
