### Rationale

ICRA has withdrawn the ratings assigned to the bank facilities of Sona Processors (India) Limited in accordance with its withdrawal policy and closure of the rated facilities, as evidenced by the No Due Certificate issued by the lenders. Consequently, there are no dues pending from Sona Processors (India) Limited towards the rated bank facilities, and the withdrawal is based on the confirmation received from the lenders regarding the same. ### About the company

Incorporated in 1994, Sona Processors (India) Limited (SPIL) primarily undertakes processing of fabrics on job work basis. SPIL's processing plant is located in Bhilwara, Rajasthan, and has an installed processing capacity for about 40 million meters fabric per annum (4 stenters; textile fabric finishing machine used for drying, shrinking, chemical finishing and adjusting fabric width). In addition to the fabric processing business, the company has also invested in a 1.6 MW wind turbine generator.

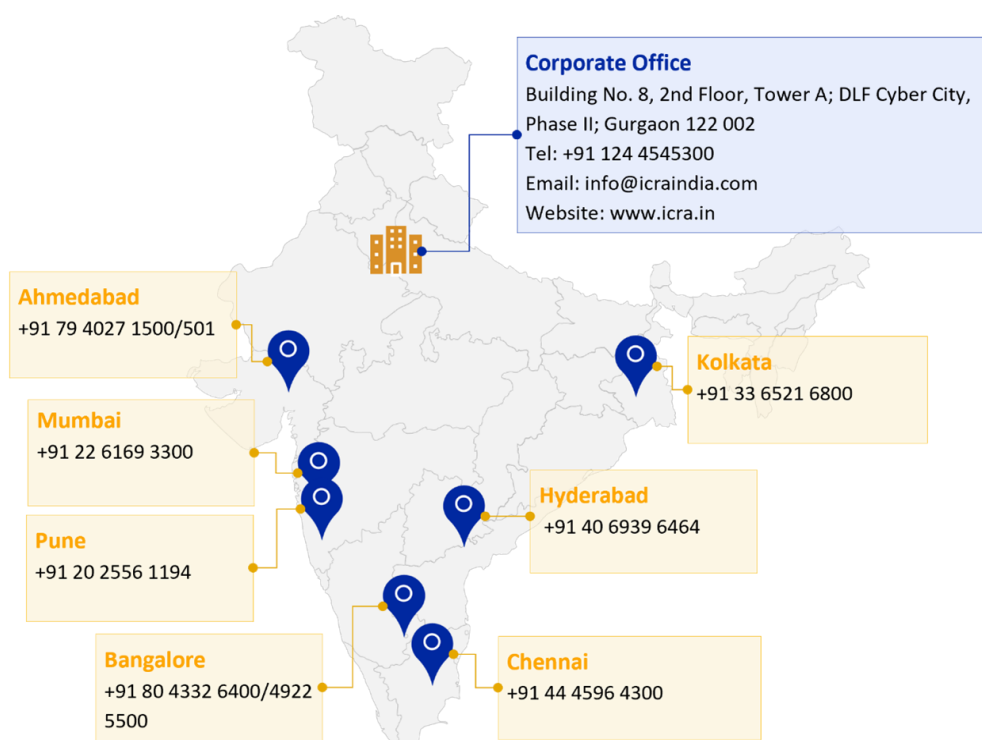
