Ruttonsha International Rectifier Limited (RIRL) announced its quarterly results on August 12, 2017.

During Q1 FY2018, as per unaudited financials, RIRL reported a net profit of Rs. 0.08 crore on an operating income (OI) of Rs. 5.19 crore, as against a net profit of Rs. 0.43 crore on an OI of Rs. 7.12 crore in Q1 FY2017. While the de-growth in revenues is attributable to a temporary disruption in demand prior to the Goods and Services Tax (GST) implementation, the decline in margins is due to the under-absorption of fixed overheads. The operations are expected to recover in the subsequent months, and ICRA will continue to closely monitor the company's performance for the same.

ICRA currently has outstanding ratings of [ICRA]BB+(Stable)/[ICRA]A4+ for the bank facilities of RIRL. The ratings derive comfort from the promoter's extensive experience in manufacturing semi-conductor devices and power equipment. The company's strong in-house technical know-how and manufacturing capability, along with its pre-qualification status from various reputed private entities and public sector undertakings (PSUs), provide additional comfort.
